National Migration Registry (RNM)

Here is a summary of the process:



1. Fill out the form

Fill out the Registration Form for Immigrants Holding a Temporary Visa (Registro de Imigrante detentor de Visto Temporário) on the Federal Police website.

2. Schedule a visit to the Federal Police

Schedule for the nearest day on the Federal Police website.

3. GRU issuance


Issue the payment slip for the Union Collection Guide, in portuguese Guia de Recolhimento da União (GRU), which pays the amount of the requested document.

4. Attend the Federal Police

Bring all the documents requested on the website for the visit to the Federal Police, in order to obtain the RNM.

Fill out the RNM Form



1.1 Access the MIGRATION section on the Federal Police website

Access the following options:

- 1.1 “Registering as a Foreigner in Brazil”
- 1.2 “Steps to perform this service”
- 1.3 Within the “Request Registration” topic, access the “Fill out form” link
- 1.4 Within the Forms section, access “Registration of immigrant holding a temporary visa”

1.1.2 Fill out the CRNM Form and print it

Important:

- 2.1 All fields marked in red are mandatory
- 2.2 Under “Type of Registration” choose “Registro de Visto Consular”
- 2.3 In “Main Occupation” choose/write “Estudante” (930 – Student)
- 2.4 In the “Business Address / School Address” section, enter the following information:



Schedule your visit to the Federal Police

1. On the same summary page of the form for the RNM, click on **“Schedule Appointment”** to be redirected to the **Federal Police Scheduling System page**

- In **“Select the desired service”** choose **“migration”**
- In **“request or application code”** copy this code that was generated in the form
- Select the closest day and time according to your availability.

Generate the GRU bank payment slip.

1. The **Guia de Recolhimento da União (GRU)** is a document generated by the government for payments made to Brazilian public institutions. You will generate a document for payment of your RNM.

1.3. Return to the **MIGRATION** section on the Federal Police website

3.1 Select the “include GRU” option

Once you have the necessary documentation, fill out the form, according to the desired method.

Service procedures when the computerized system is unavailable

The issuance of the CRNM is a digital service, which does not allow paper requests, and we do not have offline service. Therefore, if the system is down, [contact the migration service of the Federal Police unit in your State](#).

3.2 You will be redirected to the Guia de Recolhimento da União Issuance website.


Fill in all required fields

- In “**STN Revenue Code**” enter 140120
- The fee for issuing the National Migration Registration Card (in January/2025) is R\$204.77
- 3.3 After filling in the form, click on “pay” and the GRU will be generated and must be paid at any Brazilian bank.

3.4 Retain the proof of payment and bring it with you to your appointment at the Federal Police.

Be aware of the necessary documentation to bring on the day of your visit to the Federal Police.

1.4. Return to the **MIGRATION** section on the Federal Police website

4.1 Select the link in the “Documentation” section

4.2 You will be redirected to the “Registering as a foreigner in Brazil” page. Select the option “Registration of immigrant holding a temporary visa”

REGISTRATION OF IMMIGRANT HOLDER OF TEMPORARY VISA

- Own request, using an electronic form duly completed on the PF website ([click here](#));
- Valid travel document or other document proving identity and nationality, in accordance with the treaties to which the country is a party;
- Original visa form;
- Proof of payment of the CRNM issuance fee (revenue code 140120, amount R\$204.77), when applicable (to issue the Union Collection Guide, [click here](#));
- Identification document of the caller (for family reunion visa);
- In case of unavailability of the Federal Police biometric data collection system, 1 (one) recent 3x4 photo, in color, white background, plain paper, from the front, may be requested;
- Please note the **following observations** (depending on the case, other documents may be required).

4.3 Print all your documentation to take to the Federal Police on the scheduled day.

ADDITIONAL INFORMATION

Don't forget to bring with you the Original Visa Form - Issued at the Consulate

Bring a 3x4 photo from your country so you don't have to take the photo when you arrive in Brazil.

If possible, schedule your visit to the Federal Police before your trip, to avoid the risk of no available appointment dates nearby (If you manage to schedule, bring the scheduling confirmation, as well as the form and GRU already printed).

If it is not possible to pay the fee for issuing the National Migration Registry card in your country, bring the amount corresponding to the payment with you.

Pay attention to the deadlines and instructions for requesting renewal of the RNM (the document must be renewed annually)
